**NATIONAL CONFERENCE OF INSURANCE GUARANTY FUNDS  
ELECTS NEW BOARD MEMBERS**

**Indianapolis, IN, June 3, 2011** – The National Conference of Guaranty Funds (NCIGF) has elected new board members at the organization's 2011 annual meeting in Memphis.

NCIGF members elected the following individuals to serve terms on the NCIGF board:

**Charles P. Breitstadt**

Charles P. Breitstadt is Senior Director of Government Relations for the Nationwide Insurance Enterprise in Columbus, Ohio. A resident of Dublin, Ohio, Breitstadt oversees Nationwide's National Association of Insurance Commissioners (NAIC) Relations. He is also responsible for managing general regulatory affairs and guaranty funds-related issues for all Nationwide Companies, including the Allied Group.

**David C. Edwards**

David C. Edwards is President of Western Guaranty Fund Services (WGFS), a multi-state organization made up of six state guaranty associations.

Edwards has worked in the insurance industry since 1965, when he was hired as a multi-line adjuster for The Travelers. A resident of Denver, Colorado, Edwards experience in insurer insolvencies began in 1986 when he was retained as a claim consultant by the deputy receiver of the Western Preferred Casualty Company, a Colorado insolvency.

In 1998 Edwards joined WGFS as claims manager. He was appointed President of the organization in 2003. Dave is a member of numerous insolvency coordinating committees and NCIGF committees, including the NCIGF board's Executive Committee.

**Larry Hinton**

Larry Hinton serves as Senior Counsel for GEICO, where he's worked since 1997. A resident of Bowie, Maryland, Hinton's responsibilities include a range of legislative regulatory-related activities, and market conduct examinations.

From 1989 to 1997 Hinton served the District of Columbia Department of Insurance as Senior Counsel in the Office of General Counsel with responsibilities for agent and company compliance, fraud enforcement, legislative drafting and implementation, financial and insolvency proceedings including administrative hearings for suspension or revocation of company Certificate of Authority. He currently serves on the Maryland, Vermont Guaranty Fund Board of Director and is the Chairman of the District of Columbia Board of Director.

Craig A. Johnson will become President, Chief Executive Officer, and member of the Board of Directors of FCCI Insurance Group on June 3. He also is on the board of the National Organization of Life & Health Insurance Guaranty Associations (NOLHGA) and is Chairman of its Members Participation Council.
