## CIRCULAR LETTER TO ALL MEMBER INSURERS

## Re: Assessment – Company Insolvency United Property & Casualty

During a meeting held on March 7, 2023, the Board of Directors of this Association reviewed the Association's financial position and obligations in connection with the current insolvency and voted to take the following action:

## Assessment – United Property & Casualty Insolvency (All Other Account)

The Board of Directors voted to assess member insurers in the total amount of \$10,000,000 to provide funds necessary to support the Association's task of discharging its obligations arising from the insolvency of United Property & Casualty Insurance Company. The Company was declared insolvent and placed in liquidation effective February 27, 2023. The assessment was developed on the basis of the following:

Account	Assessment	Premium Base	Assessment Factor
All Other *	\$ 10,000,000	\$ 7,610,899,103	.001313905

\*This assessment is eligible for premium tax credits.

The "all other" assessment is based upon the respective total 2021 net direct written insurance premiums, less dividends, as shown on Statutory Page 14 of the 2021 North Carolina Annual Statements. The assessment factor above was determined by relating the respective assessment amount to the total premium base which includes the 2021 writings of all current members of this Association.

If a statement is attached, it shows (1) your Company's premiums utilized in determining the assessments; (2) the assessment amount for each insolvency and account; (3) the net amount due this association.
